Introduction

This report covers the year from 1st April 2023 to 31st March 2024. The impact of the Covid-19 pandemic which reduced membership activity has finally with a lot more members begining to meet again sometimes totally in person, sometimes totally virtual and sometimes a blend of both virtual and in person. This report sets out the very activities of the Executive Committee since 1st April 2022. All meetings were held in person.

Membership

Society Membership stands at 81, Individual Membership, 23. More societies became active during the year and societies ceased operations and three new societies admitted as members. A number of societies have still to renew their membership for the year despite several reminders.

The Executive Committee decided to continue the reduction of membership fees to a flat rate of £50.00 for the 2023-2024 year, however this needs to be reviewed as the income is currently not covering the costs of running the organisation with a gradual decline in our reserves.

Ian was a housing consultant and formerly the Group Chief Executive of Choice Housing, the largest local social housing provider with over 10,000 social housing units throughout Ireland. Choice was also responsible for the largest portfolio in

the provision of supported housing accommodation with 44 joint management partners, such as Charities who provide support for disability living. Ian was a graduate of both

Queen's University and the University of Ulster and was involved with providing support for refugees from Africa arriving in Northern Ireland and many other charities.

Insurance

The Federation continues to provide public liability insurance for its member societies in Northern Ireland. Insurance is negotiated every three years with the most recent negations taking place in March 2024. A small increase was agreed for the next three years resulting in societies being charged £30 per annum an increase of £5 on the previous year. This is still very cost effective when compared to insurance purchased by member societies individually.

Due North

Due to various reasons Due North wasn't printed in 2023. However with a revamped editorial committee Due North will reappear in 2024 in time for the Annual General Meeting. Thanks are due to all the contributors who provided the articles needed to make the publication possible. More articles from member societies would be greatly appreciated.

The 2023 AGM was held on 9th December 2023 in The Seamus Heany Home Place, Main Street, Bellaghy. There was a good attendance

Very little website activity happened during the year. A special meeting of the Trustees was held in August 2023 to review the website with the priority to update articles and revamp the website throughout the remainder of 2023 and early 2024. News-letter

Financial Review

The Federation finances remain sound with adequate resources instantly available (bank current account). We continue to monitor our accounts regularly, and will take appropriate action if the occasion demands it. A detailed report will be provided by the Treasurer.

Income is generated from membership fees, insurance contributions and sales of Due North, all of which were maintained during the year. As a lot of member societies were only starting to get back to business after the Covid 19 pandemic during the year, substantial reductions on both membership fees and insurance contributions were given.
